**Thorne accomplishes its mission through three unique programs:
Summer Camp - Established in 1957, Thorne Summer Camp in Boulder and Littleton reaches 2,700 youth each summer through field-based "Camp Experiences" for kids ages 3-15. Learning takes place through hands-on, science-based, experiential activities. Popular camps like, Mud Mucking, At Home in the Woods, and Bird Banding utilize local prairie grasslands, evergreen forests, and wetland habitats as a classroom and enable youth to connect with and learn about nature. To ensure that no child is ever turned away from participating due to financial need, Thorne awards \$120,000 (20% of sales) inscholarships annually.

Volunteer and in-kind support play a critical role in the success of Thorne's mission, by ensuring all programs are delivered through the most cost effective means possible.

Volunteer Involvement:

During 2016, Thorne Nature Experience utilized 125 volunteers and interns who contributed more than 6,099 volunteer hours. Thorne is governed by a volunteer Board of Trustees who oversee policy level decisions for the organization, hire and managed the Executive Director, and ensure Thorne's financial health and well being. Additional volunteers and interns provided support both in the office and with Thorne programs. Thorne has a successful internship program for undergraduate and graduate students to gain hands-on experience with teaching outdoors in nature. Typical volunteer tasks at Thorne include: assembling student-authored Mini Books and creating teaching props for Thorne's In-School Program, assisting teachers and students in the After School Program, serving as Teaching Assistants for Summer Camp, identifying and eradicating invasive plants species at Sombrero Marsh, and procuring auction items for Thorne's annual fundraiser, Natural Night Out.

Boulder Open Space and Mountain Parks Department and the Boulder Valley School District (BVSD), and expanded in 2016 to include students from St Vrain Valley Scholld District (SVVSD) through a partnership with the City of Longmont Parks and Recreation, the Field Trip Program engages 2,000 second graders annually in a day-long field trip to the 45-acre Sombrero Marsh Environmental Education Center in Boulder or Sandstone Ranch in Longmont. During field trips, students learn about wetland ecology, view birds from a bird blind, and undertake scientific experiments. In addition to serving 2nd graders, Thorne also offers Field Trips to other BVSD and SVVSD grade levels and private schools and youth-serving organizations at both its Boulder and Littleton locations.

In-School Program - Initiated in 2005, Thorne's In-School Program reaches 7,000 elementary students each year. The In-School Program expands students' knowledge in the areas of science and literacy through a three class series of lessons that involve interactive explorations, inquiry-based experiments, scientific instruments and specimens, and writing a picture book. Emphasis is placed on working with schools neighboring Thorne's environmental education centers and low-income, low-scoring, and culturally diverse schools throughout the Denver and Boulder Metro Area. At select schools with very high percentages of disadvantaged youth, Thorne offers an additional twelve week After School Program for students who are interested in expanding their knowledge of science and connection to

b) a compensation arrangement with the corporation or with any entity or individual with which the corporation has a transaction or arrangement, or

c) a potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which the corporation is negotiating a transaction or arrangement.

Compensation includes direct and indirect remuneration as well as gifts or favors that are substantial in nature.

Section 3. Procedures

1. **Duty to Disclose:** In connection with any actual or possible conflicts of interest, an interested person must disclose the existence and nature of his or her financial interest to the directors, officers and/or members of committees with Board-delegated powers considering the proposed transaction or arrangement.

2. **Determining Whether a Conflict of Interest Exists:** After disclosure of the financial interest, the interested person shall leave the Board or committee meeting while the financial interest is discussed and voted upon.

The remaining Board or committee members shall decide if a conflict of interest exists.

3. Procedures for Addressing the Conflict of Interest:

a) The chairperson of the Board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.

b) After exercising due diligence, the Board or committee shall determine whether the corporation can obtain a more advantageous transaction or arrangement with reasonable efforts from a person or entity that would not give rise to a conflict of interest.

c) If a more advantageous transaction or arrangement is not reasonably attainable under circumstances that would not give rise to a conflict of interest, the Board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the corporation's best interests and for its own benefit and whether the transaction is fair and reasonable to the corporation and shall make its

decision as to whether to enter into the transaction or arrangement in conformity with such determination.

4. Violations of the Conflicts of Interest Policy:

a) If the Board or committee has reasonable cause to believe that a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose.

b) If, after hearing the response of the member and making such further inquiry and investigation as may be warranted in the circumstances, the Board or committee determines that the member has in fact failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

Section 4. Records of Proceedings

The minutes of the Board and all committees with Board-delegated powers shall contain:

a) The names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the Board's or committee's decision as to whether a conflict of interest in fact existed.

b) The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement that were considered, and a record of any votes taken in connection therewith.

Section 5. Compensation Committees

a) A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the

corporation for services is precluded from voting on matters pertaining to that member's compensation.

b) A voting member of any committee whose jurisdiction includes compensation matters is precluded from voting on matters pertaining to the compensation of any individual with whom the voting member in question has a family relationship.

- a) has received a copy of the conflicts of interest policy,
- b) has read and understands the policy,
- c) has agreed to comply with the policy, and
- d) understands that the corporation is a charitable organization and that in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.
